


Name(s) of the persons mentioned in sub clause-(x) and (xi) noted above shall be notified by the Urban Development and Housing Department.

- 2) Appointment of The Vice-chairman of this Metropolitan Area Authority, and office, Terms of office and others of the planning Authority shall be determined by the Urban Development and Housing Department as per corresponding sections of the Bihar Urban Planning and Development Act, 2012. as well as corresponding rules of Bihar Urban Planning and Development Rule, 2014.
- 3) This Authority shall exercise its powers prescribed in the said Act and Rule for execution of its duties.
